AKCA Koi of the Year Rules and Regulations

All affiliated Clubs will be entitled to one Koi Photo Entry, which will represent your club in the photo competition at this year's AKCA Annual Seminar. The recommended guidelines for selection of a fish are enclosed. You will also find an order form for a Plaque (if your club is holding an Official Koi Show to select your entry). and instructions for participation at the Seminar.

Selection

• Clubs selecting their entry at their Koi Show:

- A committee of 2 or 3 members can select a winner at the show.
- The Judge of the show can select a winner.
- The Grand Champion of your show is not eligible.

• Clubs selecting their entry at another type of Function:

- All interested members can submit a photo and negative of their favorite Koi at a selected club meeting where all of the attendees will vote a winner.
- During a pond tour, have the attendees vote the best pond. Later a committee of 2 or 3 members can go to this home and select a fish and photograph it.
- During a club display at a Garden Show, Rose Show, Japanese Festival or Pet Fair, have the attendees vote for a favorite fish.

Guidelines

- The club must have some kind of judging, such as a photo contest, koi show, exhibit at a fair.
- The results and a **digital photo (8X10) with a resolution of 300dpi** must be e-mailed or mailed to Garry Chin **no later than April 1** to qualify for the annual seminar contest.
- Only one fish per club per year may be entered.
- The fish must be kept at the owner's home, in the owner's pond
- A fish can only be entered once per year and can only represent one club.
- All "AKCA Koi of the Year" previous first place winners, cannot be entered another year.
- ONLY clubs that hold shows and select their entrant at that show are entitled to an AKCA Plaque.
- We recommend that Koi Dealer/members be excluded from consideration.
- The Grand Champion of a Koi show is not eligible to represent that club.

Photos of all entrants will be featured in KOI USA and AKCA web-site.

All Photos will be protected and engraved by AKCA

Only club AKCA Dir/Reps may submit Koi of the Year nomination.

Champion of Champions

Each year, at the AKCA Seminar, the AKCA Judges select the Champion of Champions. Eligible Show Grand Champions must have won between May 1 to the following April 30th. Only current affiliated AKCA Club that have a Koi Show should submit a negative and snap shot, "NO DIGITALS" with Appendix v of their show's Grand Champion for this judging to

Koi Person of the Year

Each year, prior to the AKCA Annual Seminar in June, each current affiliated club is asked to select a "Koi Person of the Year." He/She (from the same household) can be chosen using whatever method or criteria that your club decides is appropriate. Koi Person of the Year is someone who has made a significant contribution to Koi keeping and/or to your club during the past year.

At the Seminar, the "Koi Person of the Year" from each club is presented with a framed award certificate. The name or couple's name of your club's Koi Person of the Year should be transmitted via the on line form at www.akca.org/forms/koiperson.htm **no later than May 1**, of each year . Use the form "Koi Person of the Year" (*appendix ix*) as a guide to the information necessary. Award certificates not claimed at the seminar will be mailed to the owner after the seminar.

Speaker Grant Lottery

Once every year (October), all eligible AKCA clubs, except those not having been an AKCA club for at least 3 prior years, or a past winner of the lottery during the 5 prior years, will be put into one of six territorial lottery groups. One winner will be chosen from each territory, announced in the AKCA minutes and each winning club will be individually notified. The 6 winners have until Sept 30th of the following year to use this grant, or if they choose to decline the grant, there will be another drawing from that territory's group and the decliner's club name will be placed back into the next year's drawing. This lottery grant is for reimbursement of one speaker's transportation and one night's lodging, a max of \$400.00. Receipts must accompany the request for reimbursement. This grant does not include any speaker fees or meal costs.

Koi Health Advisor Program

It is expected that the program will train about 250 KHAs over the course of the project. There will be a new class starting July 2009 for any one in an AKCA club. Classes will be primarily electronically taught with course material posted on the AKCA Internet web site which is expected to be freely accessible to all those with Internet access. Q&A will be handled for the official KHA students only on a closed (KHA students, instructors and CRC members only) web board. Additionally, hands on lab sessions are expected to be held during each class. KHA certified people are intended to adjunct and not replace a veterinarian. It is expected that the areas covered by the AKCA clubs will be grouped into nine regions, with three regions per class, so that the lab classes may be held within those regions hopefully making travel to attend them easier and less expensive. Liability Insurance

Included with your club's AKCA annual dues of \$100.00 is Liability Insurance for clubs **in the US only**. This will cover all regularly scheduled meetings and official club events, regardless of location, up to \$1,000,000.00 General Aggregate. If your show or display requires a 3rd party (hotel, Mall) be covered by AKCA Insurance, use the form "AKCA Certificate of Insurance Request Form" (**appendix vi**) only when a certificate of insurance requested. only requests from the club Director/Representative of record each summer will be processed by the insurance carrier

AKCA INSURANCE EXPLAINED

HISTORY: During the early 90's AKCA did not offer liability insurance as part of its membership. Any koi club that needed liability insurance to protect the club or enable it to have a koi show or exhibit at a garden show had to obtain their own insurance through Maryland Casualty. At that time the annual premium was a minimum of \$137.00. Without this liability policy the clubs were unable to hold a public function as most owners of the venue demanded a liability policy endorsement naming that particular property owner as an additional insured for the specific function. Around 1992 Maryland Casualty withdrew from this particular line of insurance and sent notices of non-renewal to all koi clubs that they would not renew their liability policies when they expired the following year. AKCA then started a search for a replacement insurance carrier.

INTENT: AKCA wanted to obtain a liability insurance policy that would protect all the AKCA member clubs and every individual member of every member club against liability claims by the public, and to facilitate clubs being able to have public functions such as koi shows and exhibits. This is what has been accomplished and is a part of the AKCA dues. In the club kit there is a form that a club fills out and sends the request for an insurance certificate to our insurance agent WES BANNISTER and ASSOCIATES. A certificate is issued to the property owner that names that property owner as an ADDITIONAL NAMED INSURED for that specific event.

WHAT IS COVERED: As stated above this is a liability policy that protects the insured. By definition all member clubs and their members are insured. If somebody files a claim against a club and/or club member this policy will defend that individual or club and either settle the claim or defend a lawsuit and pay whatever award (within the policy limits). Additionally the ADDITIONAL INSURED that was named on the aforementioned insurance certificate will be treated as an insured, and defended accordingly. One other coverage is not a liability coverage, it is MEDICAL PAYMENTS, which basically says the insurer will pay for all REASONABLE and NECESSARY medical expenses WITHOUT REGARD TO LIABILITY for any person (NOT INSURED) that was injured at this public function, up to the limits of the MEDICAL PAYMENTS COVERAGE. This coverage would apply at a regular club meeting to any GUESTS at the meeting.

WHAT IS NOT COVERED: If a club member sues a club or one of its members for some alleged negligent act, this policy does not afford coverage as this would in essence be one insured suing another insured. And the PRINCIPLES OF INSURANCE do not allow an insurance carrier to write a liability policy that allows an insured to sue themselves as this would lead to many instances of fraudulent insurance claims. Additionally this policy does not afford coverage to the property owned by any member club. MEDICAL PAYMENTS COVERAGE is also excluded for insureds.

OVERVIEW: AKCA is aware that there may be other insurance coverage an individual club may wish to have but since our member clubs are all throughout the USA there are a limited number of insurance carriers that can offer insurance in all 50 STATES. It is suggested that each club review their own specific insurance needs and obtain the additional coverage as is deemed appropriate in their own area. Most frequently asked question is in regards to a member club's personal property. Many clubs have a sizeable investment in their show tanks, pumps, blowers, microscopes, etc. and whether to insure these items for fire, etc. is an individual club decision.

INSURANCE CERTIFICATE REQUESTS

AN INSURANCE CERTIFICATE CONFIRMS THAT YOUR CLUB HAS THE REQUIRED LIABILITY INSURANCE POLICY.

DO NOT REQUEST AN INSURANCE CERTIFICATE for any event unless you are required to supply proof of insurance to actually hold your event.

POND TOURS DO NOT REQUIRE INSURANCE CERTIFICATES - as the members of your club are already insured and this is a MAJOR waste of the insurance carrier's resources, and will just cost higher premiums for AKCA.

ADDITIONAL INSURED INSURANCE CERTIFICATE - This is when a venue holder requires that they are added onto the AKCA policy as an ADDITIONAL INSURED during the event you are holding on their property such as a koi show , or some exhibit at a mall or garden show, etc .When the venue requests this type insurance certificate you MUST GET the wording VERBATIM that the venue holder wants on this certificate directly from the venue holder.

ALL REQUESTS FOR INSURANCE CERTIFICATES must be emailed to Burt Ballou at burtb@socal.rr.com or faxed to (714) 839-5016 at the same time the certificate is requested from Hartford. The reason is, if there are any issues Hartford has before issuing the requested certificate, they will not contact the certificate requestor; they will only contact Burt Ballou to resolve certificate related issues.

ANY REQUESTS BY ANYONE OTHER THAN A CURRENT AKCA MEMBER CLUB WILL NOT BE VALID AND NO INSURANCE WILL APPLY.

Directors/Representatives

AKCA is a registered non-profit organization with by-laws that support all Koi clubs that affiliate with it on an annual basis. The by-laws state that each club is represented by one vote on the Board of Directors. AKCA Club Directors/Representatives are the identified votes of the AKCA BOARD. Therefore, the AKCA Rep should be a club officer or someone that can take the pulse of the club on issues concerning the Koi hobby. The job description of the AKCA Director/Representative is as follows:

- a) Represent AKCA in his/her chapter area.
- b) Read the AKCA Board minutes upon arrival.
- c) Determine club position on issues.
- d) Vote the club position when asked.
- e) Communicate club responses when required.
- f) Develop issues which effect Koi keeping as AKCA agenda items.
- g) Assure that club input is received by the AKCA board.
- h) Serve as requested by AKCA Board Chairman.
- j) Support AKCA activities.
- h) default mailing address for AKCA Minutes, AKCA Guides and Complimentary KOIUSA
- i) contact your club's assigned local Board member at least every other month to discuss club and AKCA activities and concerns.
- j) provide the Membership Committee Chairman with any changes to the required club

information following an annual election of your club officers or when the information changes including address, phone numbers or email addresses by using Appendix i or via email to [judgedahl@hotmail.com](mailto:judgetahl@hotmail.com)

Under the AKCA bylaws, each AKCA Club is to elect one (1) member as the delegate and one (1) member as an alternate to the Board of Directors of the Associated Koi Clubs of America, Inc.

These Directors (or AKCA representatives) will cast one (1) vote per club on the AKCA officers which are elected each year in May and on other items as specified in the bylaws. The minutes and meeting notices for each AKCA Board of Directors meetings are mailed to the representative designated as Director #1. Director # 2 will serve as an alternate. If your Director cannot attend the AKCA Board meetings, Director #1 will receive a telephone call at least every other month preceding the meeting from another AKCA Board member (your club's contact) so that your club's views can be considered at all AKCA Board meetings.

Your club's AKCA Director and alternate can be elected or appointed by your club and/or can be your President or another officer. Article X of the AKCA By-Laws requires AKCA Directors may not be Koi dealers or representative of Koi Dealers.

The names of your club's Directors and Officers should be transmitted each year, or when there is a change in the information, using the form "Club Information Changes for AKCA" (appendix i). A request for this information will be emailed to each club AKCA Dir/Rep the month following club election of Officers.

Club Directors/Representatives not able to attend the AKCA Board Meetings should send written proxy authorization, signed by the club Director/Representative, allowing their local Board Member Contact to represent them in an AKCA Board Meeting vote and to place motions before the Board.
